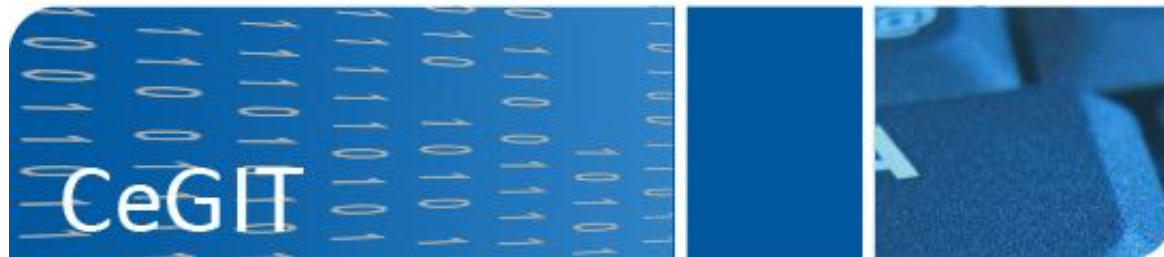

Lizenzen

- Unabhängig von einem eventuell bestehenden Softwarepatent können Software und Daten von den Urhebern **lizensiert** werden.
- Software Lizenzen werden abhängig von der Verfügbarkeit des Software-Quellcodes eingeteilt:
 - **Geschlossene Lizenzen („Closed Source“)**
 - **Offene / Freie Lizenzen („Open Source“)**
- **Diese Präsentation beleuchtet die Möglichkeiten im Bereich der „freien“ Lizenzen.**

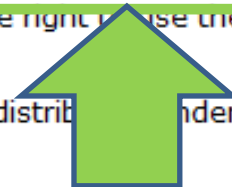

- Die (neu)-gewählte Lizenz soll der **Philosophie** der (bestehenden) Gemeinschaft entsprechen.
- Eine Lizenz gibt die **Regeln** für eine neue (Entwickler-) Gemeinschaft vor.
- Unterschiedliche Lizenzen schaffen unterschiedliche Gemeinschaften

- Sicherstellung der Code-Offenheit

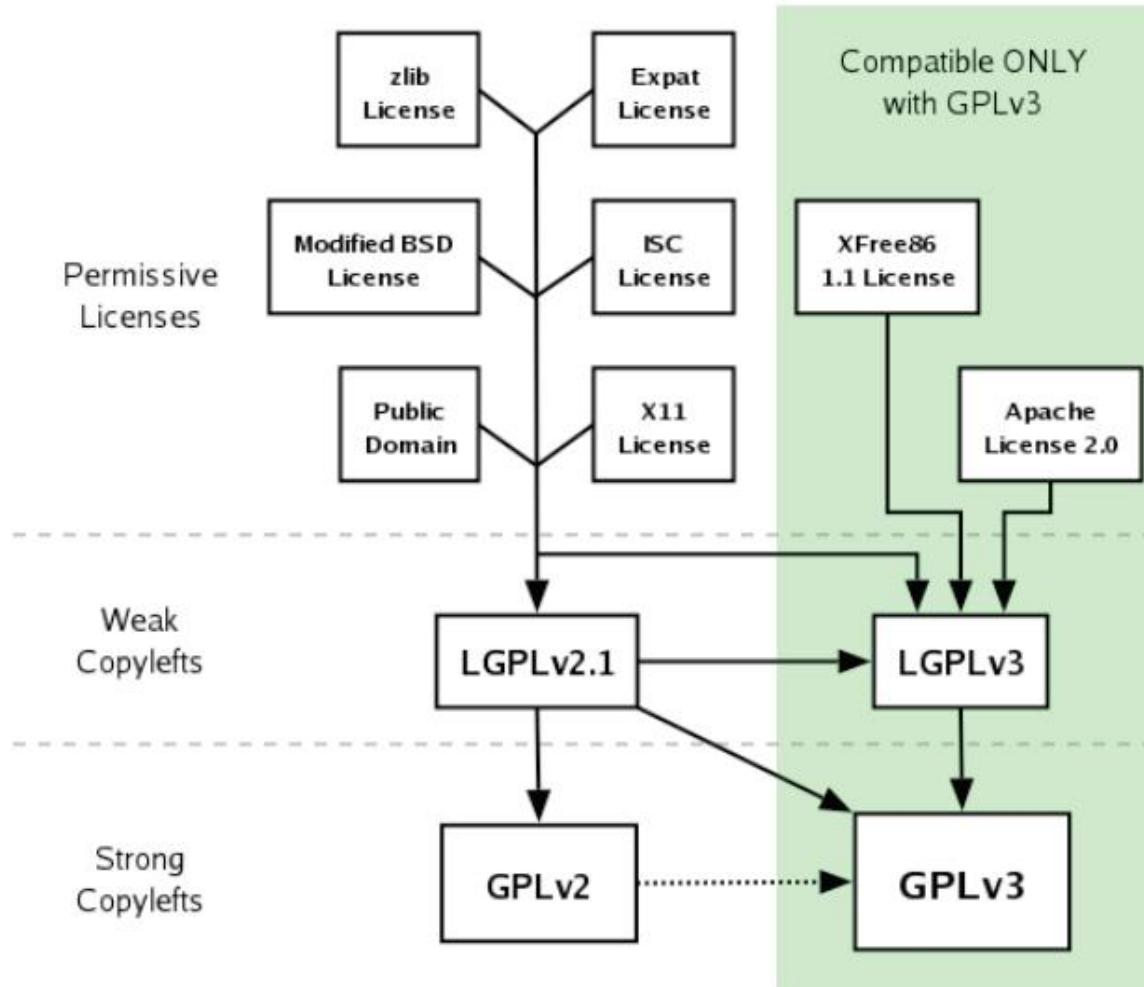
